Dr. BS Boparai said that HP-PERC approved 30 seats in M. Sc. Course during the academic session 2017-18 near the last date of admission but no student could be admitted. Hence the course curriculum was not approved earlier. Dr. BS Boparai further said that during the Academic session 2018-19, HP-PERC approved the intake of 4 seats in M. Sc. Horticulture and all the seats have been filled up.

Dr. BS Boparai said that to finalize the course structure and course contents of M. Sc. Horticulture a meeting of the members of Board of Studies was held on 16th Jun 2018 at Punjab Agriculture University, Ludhiana in which the following experts gave their consent:

Dr. BS Boparai described the following aims of this programme:

- To introduce the students to the importance and technology/knowledge of integrated and ecological production of fruits, vegetables, ornamental plants, medicinal and aromatic plants.
- To help the students to learn about the different cultivation techniques used for horticulture crops, the lay-out of orchard, pruning and modern training system, descriptions of commercially available varieties and promising new varieties, harvesting and the major pests and diseases of the crops.
- To acquaint with management and organisation of protected cultivation, with equipment and methods used for growth regulation and increase of productivity of horticulture crops.
- To get the study of basic principles of post-harvest physiology in fresh fruit.

Dr. BS Boparai also enlightened on the following outcomes of this programme:



- (a) This programme will help the students to plan the horticulture production and effectively use the new horticultural technologies.
- (b) To provide the skills to orient in problems of quality and sales of ecological and integrated production.
- (c) Ability to understand the physiology of growth and flowering and orchard management of commercial fruit species.
- (d) Ability to apply profile horticulture knowledge in optimisation of production technology in fruit, vegetables and ornaments.
- (e) Ability to theoretically and technology/knowledge in optimisation practise at postharvest equipment and acquire the knowledge of storage technology of fruits, vegetables and flowers.

Hon'ble Vice Chancellor said that on 10th August, 2018, Dr. MM Sharma, Joint Director, Department of Horticulture, HP, Shimla visited our university along with one representative from Dr. YS Parmar University, Nauni and another from Rajgarh. During his visit, Dr. MM Sharma suggested that there should not be a degree in Horticulture as there are several areas of specializations. Hon'ble Vice Chancellor replied that the point will be discussed in the Academic Council meeting and decision will be taken on the consent of all the Hon'ble members.

Hon'ble Vice Chancellor told that Dr. MM Sharma and his team visited the university on their own choice and were not instructed by the Department of Higher Education, Shimla. Hon'ble Vice Chancellor asked Dr. Ramesh Arora to inform the house as to how Dr. MM Sharma planned his visit. Dr. Ramesh Arora told that in a meeting held at the Department of Higher Education Shimla for the finalization of Fee structure, Dr. MM Sharma was present as a representative of his department and he asked to see the infrastructure of Horticulture in our university. Accordingly, an invitation for his visit was sent which he accepted and planned his visit for this purpose.

Hon'ble Vice Chancellor said that our university will offer M. Sc. in Horticulture overall and the specialization will be based on the topic of student's thesis.

Dr. PS Cheema briefed the syllabus through a PPT in the house. He told that total load has been reduced to 160 credits over four years. Dr. PS Cheema told that some of the observations/suggestions made by the external experts have been implemented.

The time frame of this syllabus was critically observed by Dr. BS Sohal which was earlier framed for 373 days i.e. more than the period of academic calendar. Dr. PS Cheema clarified this observation and said that the duration of the course will remain in tune with academic calendar and period of minimum 45 days will be followed through online mode.

Dr. BS Sohal said that it will not be possible for the examination branch to prepare the DMCs if the syllabus is revised after every semester. Dr. PS Cheema replied that the syllabus will not be changed after every semester, however, the complete syllabus will be revised after one year under supervision of a standing committee including industry experts, external academic experts, Dean ACET & Dean Academic Affairs. The subjects of both the semesters will be evaluated by the committee according to the latest need of Industry. Dr. BS Sohal agreed to accept the B. Tech. CSE Syllabus once approved by the Academic Council and copies be provided in the shape of booklet. Dr. BS Sohal also said that Examination branch will not be in a position to provide a proper syllabus in case someone asks it after a long duration of the course completion.

Hon'ble Vice Chancellor suggested getting a meeting together with Controller of Examination & Dean Academic Affairs so that all the relevant issues are resolved. Dr. PS Cheema agreed with the suggestion of Hon'ble Vice Chancellor.

Dr. NS Attri suggested that this syllabus may be approved for period of one year and be revised again before the commencement of next academic year i.e. 2022-23.

House approved this syllabus to be implemented for the students got admission during the academic session 2021-22 only for a period of one year i.e. current academic session 2021-22

(Action: Dean ACET, COE, Registrar Office)

Fifthly, Regarding item No 75/14/2021 Approval of Student's Handbook (Third Ordinance, Dr. SK Chauhan told that 1000 copies (bound) and 20 copies (hard bound) have got printed. One hard bound copy has already been distributed to all Deans as well as to Examination Branch, Registrar Office & VC's Office and rest 1000 copies (bound) are available with the library. Dr. SK Chauhan requested the house to decide the price for its distribution among the students. Dr. BS Sohal told that its actual cost of printing is Rs 39/- per copy and it may be sold @ Rs 50/- per copy.

Dr. Meenakshi Gupta said that the money cannot be collected by the Librarian and it is suggested that the charges be deposited with Account Branch, thereafter, the booklet will be issued to the concerned student with having a record of "Money Deposit Receipt Number & date".



In the beginning, Dr. S. K. Chauhan, Dean of Akal College of Economics, Commerce and Management cum chairman welcomed the members present in the meeting. He said that this time our college has revised the syllabus of three degree programmes viz. M. Sc Economics, Ph. D Commerce and Ph. D Management. The efforts made by the team (Dr Shanta, Mrs Dhaliwal, Dr Manjinder for Economics, Dr Kajal Chaudhary for Commerce and Dr Geeta Kumari for management) in revising the course curricula were appreciated. He directed the member secretary, Dr. Kajal Chaudhary to proceed with agenda.

Dr. Kajal Chaudhary expressed her thanks to the chairman for assigning the duty to conduct the proceedings. She requested Dr S. K Chauhan to present the first item (3/1/2021) of the agenda, that is, ratification of proceedings of 2nd meeting of BoS which was held on 17.12.2021.

While presenting the first item of the meeting, Dr S.K. Chauhan informed the house one by one the items got approved in the second BoS meeting and the action taken by the item presenters/faculty in respect of item no. 2, 3, 4 & 5. Dr Chauhan also requested the members to kindly apprise their near and dears about the new course on BBA to be commenced by our college from the next academic session initially with 30 seats. Thereafter the first item was considered ratified by the house.

The item second of agenda (3/2/2021) on the the approval of revised course curricula of Ph. D Commerce for the academic session 2021-22 was presented by Dr Kajal Chaudhary herself. She clarified that the said revised course has been got vetted from external expert Dr Devinder Sharma, Associate Professor of HPU, Shimla. The suggestions made by him are being incorporated in the syllabus. She also discussed the necessary changes made in different courses keeping in view the recent development in the business environment. Dr Simranjeet Singh sought clarification on the schedule of courses for 12 credit hours to be offered to students in first and second semester. Dr S K Chauhan replied that there should not be a binding to offer all the 12 credit hours in the very first semester if there is a shortage of faculty. However, if adequate faculty is there then all the 12 credit hours may be offered in his/her first semester. Dr Simranjeet Singh got satisfied. Thereafter, the house unanimously approved the item alongwith required modifications for further necessary action.

Third agenda item (3/3/2021) with respect to approval of revised course curricula of Ph. D Management for the academic session 2021-22 was presented by Mr. Pawan Kumar Dubey, Assistant Professor of Management. More over, the research to be carried over by the students in subsequent semesters has been thoroughly elaborated. New contents in the context of advancement in the business environment and management field under relevant units have been added. The revised syllabus has been forwarded to the expert Dr Kapit Kathuria for his opinion and the response is still awaited. The house gave its approval subject to inclusion of the comments of expert before sending it for the approval of Academic Council.

Fourth agenda item (4/3/2021) with respect to approval of revised course curricula for M. Sc Economics was presented by Dr S.K Chauhan. Dr S.K Chauhan said that lot of changes have been made in the syllabi, for example, the repetition has been removed and new contents in the relevant units have been added. Besides, it is planned to offer the major courses to students in three semesters and to keep fourth and last semester free for their thesis work to be completed on time. He further clarified that the revised course has been got vetted from an external expert Dr Virender Kumar, Professor & Head Agricultural Economics, CSK HPKV, Palampur. Dr Simranjeet Singh, Dr Mohit and Dr Surjan Singh raised a point that **research methodology course be given common course number with code of the respective department but having the same title so as to avoid difficulty in uploading the question papers on the EU portal.** The house agreed to follow uniformity and Dr S K Chauhan requested Dr Surjan Singh to help his college concerned faculty in designing the same course content and allotting the course number.

The house unanimously **approved** the item alongwith required modifications for further necessary action.

The house appreciated the work done by the team. Dean asked the office Assistant Mrs Monu to make sure that all the three reports including the present one are got uploaded on the webpage of college by 31st August, 2021 for easy access to users.

Dr. SK Chauhan said that in the Planning Board meeting, Dr. BS Sohal told that the period being covered in AQAR from 01 July to 30 June is likely to be changed by NAAC by Dec 2021 thus the existing reporting period for Annual Report and Annual Progress Assessment Report for the university employees from 01 August to 31 July need not to be changed and the existing reporting period be followed as hitherto.

Dr. SK Chauhan said that keeping in view the comments of Dr. BS Sohal, the change of reporting period for Annual Report of the University and Annual Progress Assessment Report (APAR) for the university employees was not considered.

At the beginning, Dr. S. K. Chauhan, Dean of Akal College of Economics, Commerce and Management cum chairperson welcomed the members of the house. Dr. Sudhakar Pandey, from college of AC E&T pointed that in the eligibility criteria to get the admission in the BBA alongwith percentage of marks should be mentioned.

In a list of 1st semester courses, Dr. Sudhakar Pandey further raised a point that credits of the practical of CSE-109 of IT tools in business should be again discussed with the concerned department.

In the list of 2nd semester courses, Dr. Pritesh and Dr. Surjan Singh from the college of DKSG ACA and AC BS, respectively suggested that for ENG-112 (Business Communication & Professional Ethics) the concerned department be consulted for the inclusion or exclusion of practical.

To verify the credits hours of the EDU-101 course from the respective faculty who deliver the common course for all the students of the university was suggested by Dr Surjan Singh. His concern was supported by the members of the house.

In the 5th semester, again Dr. Sudhakar Pandey pointed out that the credits of the practical of course CSE-321 (Essentials of E-Commerce) should be cross checked with the concerned department to make it clear that whether it is of two credits or more. So keeping in view the credits, the contents of the course should be adjusted accordingly.

Dr. Pritesh Vyas suggested that educational tour/ industrial visit should be included in each year of the program. The chairman of the house welcomed the suggestion and informed the house for making such arrangement depending upon availability of suitable time and needed budget.

Dr. Surjan Singh also pointed that in the courses of 1st, 2nd and 3rd semester BC-313 (Basis of Business Accounting), BC-314 (Basic of Cost Accounting) and BC-315 (Basics of Management Accounting)

respectively, the course code should be given as per the year of the program. All the members of the house also endorsed his concern.

The house unanimously gave its approval for further submission and placing the item for approval of Academic Council.



Dr. SK Chauhan again requested to Dr. SK Sharma for the presentation of this item.

Dr. SK Sharma informed the house that Hon'ble Vice Chancellor advised to submit online "Letter of Intent" (LoI) as early as possible. At the time of processing the filling this LoI on line, it was observed that the degree of M. Sc. Horticulture did not appear in the recommended course of ICAR as per their nomenclature. The courses which appeared in the recommended course of ICAR are M. Sc. Ag Horticulture (Fruit Science), M. Sc. Horticulture (Vegetable Science) and M. Sc. Horticulture (Floriculture & Landscape Architecture). Dr. Sharma told that the students admitted initially in M. Sc. Horticulture with effect from the academic session 2018-19 onward may face problems for their placement because of non-accreditation of the course. The issue was brought in notice of Hon'ble Vice Chancellor and Hon'ble members for urgent consideration

Hon'ble Vice Chancellor and the members present in the house approved that the degree to the students of M. Sc. Horticulture admitted during 2018, 2019 and 2020 be awarded on their field of specialization as M. Sc. Ag Horticulture (Fruit Science), M. Sc. Horticulture (Vegetable Science) and M. Sc. Horticulture (Floriculture & Landscape Architecture) with retrospective effect.

Dr. SK Chauhan conveyed his thanks to the Hon'ble Vice Chancellor and said that one of our external members Dr. RK Kataria, Dean, College of Agriculture, CSKHPKV, Palampur had expressed his inability to join the meeting due to his superannuation on the last date of this month i.e. 31 October, 2021.

Dr. SK Chauhan presented the agenda items as under:

76/01/2021 (i) Ratification of the proceedings of 75th meeting of Academic Council held on 19th August, 2021.

(ii) Decision taken by a committee regarding Item No 75/07/2021 (Approval of SWAYAM/MOOC courses)

(iii) Justification of Item No 75/08/2021 (Deferment of B. Tech. CSE Syllabus)

Dr. SK Chauhan said that the proceeding of last academic council was circulated among the Hon'ble members on 17th October, 2021 and comments/suggestions were invited by 20th October 2021. No comments/suggestions are received by the Registrar Office till the commencement of this meeting. However, some of the following important issues of last meeting are hereby updated as under:



Dr. BS Sohal suggested to correct the name of course against course code PH-602 and read it as "Methods in Public Health" instead of "Tools and techniques for research in Public Health".. Dr. Shaveta Menon agreed to the suggestion of Dr. BS Sohal.

Dr. SK Chauhan also observed that Course Code PH-601 contains Serial Nos from 01 to 06 whereas the other Course Codes are having Unit Numbers instead of Serial Numbers.

Dr. NS Attri also suggested that the references of study material (books) should also be incorporated in the syllabus for the interest of the scholars.

Dr. Shaveta Menon replied that she was not aware of all these aspects; anyhow, it will also be improved before its distribution.

House **approved** the syllabus subject to incorporating all the above suggestions.

76/08/2021: Approval for the revision of B. Ed. Curriculum

Dr. SK Chauhan requested Dr. Raino Bhatia to present the syllabus in the house.

Dr. Raino Bhatia said that the curriculum has been revised under the guidelines and framework of National Council of Education (NCTE). She told that the syllabus has been routed through the College Board of Studies with the following three external experts:

- Dr. Neelam Paul, Associate Professor, Government College of Education, 20D, Chandigarh
- Dr. Charanjit Kaur, Assistant Professor, Dev Samaj College of Education, 36B, Chandigarh
- Dr. Richa Chhabra, Associate Professor, Dev Samaj College of Education, 36B, Chandigarh

Dr. Raino Bhatia said that the valuable suggestions given by the external experts have been incorporated in the revised syllabus. She further said that the main objectives for revising the said curriculum have already been communicated to all the Hon'ble members by the Registrar Office along with the Item No 08 of today's agenda.

Dr. Raino Bhatia requested the house to give comment/suggestion, if any. As there was no comment/suggestion from any of the members, house **approved** the syllabus to be implemented from the Academic Session 2021-22 onwards.

76/09/2021 Approval of a Proforma for Programme of Study for PG students in Agriculture Science

Dr. SK Chauhan said that this item was to be presented by Dr. SK Sharma, Dean, DKSGACA but he being on leave requested me to present on his behalf.

Dr. SK Chauhan said that quite a large number of M. Sc. & Ph. D. Programmes are being running in Dr. Khem Singh Gill Akal College of Agriculture but the students are not submitting any report which is an essential requirement as per ICAR guidelines for the accreditation of PG programmes in agriculture sciences. He said that a draft proforma for Programme of Study for post graduate students (PSPS) was also circulated to the Hon'ble members along with the notice of the meeting. Dr. SK Chauhan again requested the Hon'ble members to give any valuable suggestion for incorporating in the form.



Hon'ble Vice Chancellor also asked whether the condition of duration for issuance of NSS certificate is two years or three years? Dr. Yogeeta Thakur replied that it is two year duration certificate and the students have to complete 240 hours and attending a NSS camp for getting NSS Certificate.

Dr. Yogeeta Thakur also said that the curriculum for this subject is also to be revised. Dr. BS Sohal said that examination branch needs some more time for seeking clarification and to frame the process of implementation of clause 2 above. Dr. SK Chauhan said that these clauses are also need to be specified in the Prospectus of 2023-24 onwards.

House agreed with the explanation of Dr. BS Sohal and approved it.

79/08/2022: Approval for 10th convocation during 2022-23

Dr. SK Chauhan informed the house that 10th convocation for the Academic Session 2021-22 was planned on 19th November, 2022 but due to cloud burst and disturbance of routine schedule of the Kalgidhar Trust and the University, it is not possible to hold it as was planned.

Dr. SK Chauhan replied that during the month of March 2023, some of meetings for Annual Budget 2023-24 are to be planned and during the month of April 2023, University remains busy for the annual function of Kisan Mela on the eve of Vaisakhi.

On the suggestion of Dr. SK Chauhan, it was decided to plan the 10th convocation during the first/second week of May 2023.

Dr. SK Chauhan requested Dr. Nasib Singh to present the item. Dr. Nasib Singh told the house that some of the minor amendments are made in the existing approved syllabus of B. Sc. (Hons) Microbiology thus was not sent to the external experts, however, the syllabus has got approved by the Board of Studies in its meeting held on 11 July 2022 at college level.

Dr. Nasib Singh told that the revision of this syllabus has been done due to following main reasons:

- Some changes are required as per NAAC criterion.
- Considering the industry-oriented and inter-disciplinary nature.
- Due to merger of courses having 70% similar contents.

Dr. BS Sohal enquired whether the course contents remained same so that the preparation of DMCs may not be changed. Dr. Nasib Singh said that the course codes have not been changed but some new course codes have been included in the revised syllabus.

Dr. SK Chauhan suggested Dr. Nasib Singh to include Programme Outcomes (POs), Programme Specific Outcomes (PSOs) and Course Outcomes (Cos) in the revised syllabus.



Dr. Krishan Kumar informed the house that there is a highly reputed laboratory fitted with gadgets and necessary modern machines in the Department of Food Technology thus it is proposed to establish a **Centre of Excellence for Food and Agriculture**.

Dr. SK Chauhan suggested to get it approved initially from the Board of Studies of the college.

Dr. DK Vatsa also suggested preparing its detailed proposal. Dr. Krishan Kumar agreed with the above suggestions.

House accorded the **approval** for starting the process to establish Centre of Excellence for Food Tech and Agriculture.

UGC has now supersede the regulation 2016 and released new notification in 2022 vide which no publication is compulsory.

Dr. Sandipan Gupta desired to know the system to be followed by the Eternal University.

Dr. AS Ahluwalia replied that publication of two papers before the submission of thesis will remain stand good for the the Ph. D. scholars as notified in the student guide 2021. However, Vice Chancellor has the authority to condone the requirement under special circumstances.

Hon'ble Vice Chancellor said that this clause should also be applicable for the students who were admitted in the academic session 2016-17 and yet to complete their degrees.






