Dr. Davinder Singh, Vice Chancellor conveyed his thanks to all the Hon'ble members on behalf of Hon'ble Baba Iqbal Singh Ji, Chancellor, Eternal University Baru Sahib. Dr. Davinder Singh told that Baba Ji is unable to join the meeting due to some health issue, however, his holiness confirmed to hold this meeting.

Hon'ble Vice Chancellor directed to Dr. SK Chauhan, Additional Registrar to start the agenda as scheduled for the meeting.

With the expression of thanks to the Chair and welcoming all the Hon'ble members present in the meeting, Dr. S.K. Chauhan informed the house that due to the present situation of COVID-19 pandemic in the country, the meeting has arranged through the mode of Google Meet.

Since the meeting was scheduled after a period of approximate 8 months due to ongoing Covid-19 pandemic, therefore, he shared some of the following important issues before starting the listed agenda:

Firstly: Dr. SK Chauhan informed the house that Dr. SK Sharma, Dean, Dr. Khem Singh Gill Akal College of Agriculture has been awarded with the "Dr. Kirti Singh lifetime Achievement Award 2019" by the Indian Society of Vegetable Science, Varanasi, on account of his outstanding contributions in teaching, research and extension activities in vegetable science. This is the highest award being awarded in the field of vegetable science in India. The house gave big applaud and all members conveyed their congratulations Dr. SK Sharma.

Secondly: Dr. SK Chauhan also told that Dr. Nasib Singh has got success for getting a project worth Rs.27.30 lakhs from DBT & HIMCOSTE for skill development in Biotechnology. The programme for

the first batch of students was started from 08th February 2021 through online mode initially due to COVID-19 situation. The house also conveyed congratulations to the young scientist for his achievement.

Thirdly: Dr. SK Chauhan told that HP-PERC constituted an inspection committee for the assessment of infrastructure of Dr. Khem Singh Gill Akal College of Agriculture to approve the demanded seats in the following courses for the academic year 2020-21:

- (a) B. Sc. (Hons) Agriculture
- (b) M. Sc. Genetics & Plant Breeding
- (c) M. Sc. Plant Pathology
- (d) M. Sc. Entomology
- (e) M. Sc. Agriculture (Agricultural Economics)

Dr. SK Chauhan told that this inspection team inspected the university on 21-22 August 2020 and submitted its report to HP-PERC with the recommendation for approving the demanded seats resulting which HP-PERC approved the above courses with the required seats on 26th August 2020.

Fourthly: Dr. SK Chauhan told that the employees and students of the University were granted the winter vacation from 24 December 20202 to 26 January 2021 but HP-PERC Shimla issued notification for the University inspection by a committee headed by Dr. KR Dhiman and two members. To make the inspection success some of the faculty/staff were recalled from their home. The inspection team comprising Dr. KR Dhiman, Chairperson, Dr. Vijay Chaudhary, Member and Mr. Vivek Thakur, Official HP-PERC got satisfied with all records, lab & field activities shown to them and especially appreciated the Akal College of Health & Allied Science and Akal College of Education for their esteemed management. The inspection team also made visit to the Dr. Khem Singh Gill Akal College of Agriculture new building under construction, apiary, dairy farm, waste management and research farms. The team expressed great satisfaction and praised the team for high level of research being undertaken on wheat and protein rich maize cultivars.

Fifthly: Dr. SK Chauhan further informed the house that after getting the permission from the Hon'ble Deputy Commissioner, Nahan, all the students of UG & PG programmes were also advised to join the university with the RT-PCR report by 26th January 2021 so that their off line study be carried out. At present all the students have joined the University campus and off line end semester examination for the first year students have also been conducted for their 1st semester. University conducted 43 Viva voca through offline mode and 14 online mode for the masters students. As regarding viva voce of Ph. D Students, 06 students qualified through online mode. Dr. SK Chauhan said that it is a great achievement of the University during this covid-19 period and credit goes to the administration for their effective and efficient management.

After sharing the above information, Dr. SK Chauhan started the agenda items for their approval.

27/01/2021 Ratification of the Proceedings of the 26th Governing Body Meeting held on August 11th, 2020

Dr. SK Chauhan said that the proceedings of the last meeting were circulated to all the Hon'ble members through email and requested to go through it and give their valuable suggestions, if any by 31st March, 2021.

As regarding item No 26/2/2020-Ratification of 25th Governing Body Meeting proceedings: Dr.SK Chauhan requested Dr. SK Sharma to inform the latest status of ICAR accreditation of the Dr. Khem Singh Gill Akal college of Agriculture. Dr. SK Sharma informed that the draft SSR has already been submitted to ICAR for which the response is awaited. The accreditation fee as well as the draft SSR will be forwarded immediately on receipt of confirmation.

As regarding item No 26/5/2020-Guidelines for release of faculty/staff during Covid-19 lock down period and release of deferred amount: Dr.SK Chauhan told that due to Covid-19, 65% salary was released to the employees till November 2020 and thereafter 80% salary was distributed for the month of December 2020 and January 2021. However, 100% salary was distributed for the month of February 2021 and deferred amount has also been paid up to August 2020.

Dr. SK Chauhan requested the Hon'ble members for any of the suggestion/comment.

As there was no comment/suggestion received from any of the Hon'ble member, the proceeding declared as ratified.

27/02/2021: Approval of 13th Annual Report for the Academic Session 2019-

Dr. SK Chauhan said that the contents of 13th Annual Report for the Academic Session 2019-20 were circulated among the Hon'ble members along with the notice of the meeting.

Dr. SK Chauhan said that this item was also placed in the Board of Management meeting held on 27th March 2021 for its approval and got approved therein.

Dr. SK Chauhan told that 75 copies of this report got printed and supplied to all the Hon'ble members of the important committees and Deans/Principals of Eternal University Constituent Colleges for their information.

Dr. SK Chauhan requested the Hon'ble members for the approval of 13th Annual Report for the Academic Session 2019-20 and also invited any valuable suggestion/comment which may be followed for the next annual report.

As there was no comment/suggestion, house approved the Annual Report 2019-20.

27/03/2021: Nomenclature/creation of departments/sections and approval of faculty/staff strength in the Dr. Khem Singh Gill Akal College of Agriculture as per ICAR guidelines

Dr. SK Chauhan said that this item was circulated among the members along with the notice of the meeting and requested Dr. SK Sharma to present the item.

Dr. SK Sharma informed the house that this item was also placed in the 72nd Academic Council Meeting held on 12 December 2020 and Board of Management meeting held on 19 December 2020. It was declared as approved in both the meetings.

Dr. Sharma further told that admission status in the DKSGACA during the Academic Session 2020-21 has been affecting adversely due to non-accreditation by the ICAR. He said that in order to submit LOI for the re-accreditation of the B. Sc. (Hons) Agriculture, the nomenclature/creation of department/section was required to be revised as per the guidelines of ICAR. Dr. SK Sharma informed that matter was given top priority and thus at present there are seven under mentioned departments in this college which were approved in the 45th Board of Management Meeting held on May 23, 2019:

- a) Department of Agronomy & Agroforestry
- b) Department of Plant Pathology
- c) Department of Entomology
- d) Department of Horticulture
- e) Department of Food Technology
- f) Department of Genetics & Plant Breeding and Biotechnology
- g) Department of Soil Science and Agriculture Chemistry

Dr. SK Sharma suggested that the name of existing two departments is recommended to be changed as under:

- (i) Department of Agronomy & Agroforestry to be read as "Department of Agronomy"
- (ii) Department of Soil Science and Agriculture Chemistry to read as "Department of Soil Science and Agricultural Chemistry"

In addition to the above, Dr. SK Sharma informed the house that as per ICAR guidelines the following additional departments/sections have also been created so that the accreditation of DKSGACA be got done at the earliest:

- a) Department of Agricultural Economics
- b) Department of Agricultural Extension & Communication
- c) Section of Animal Science
- d) Section of Agriculture Engineering
- e) Section of Biochemistry and Crop Physiology

Dr. SK Sharma requested the Hon'ble members to give any suggestion for the change of nomenclature/creation of departments/sections and approval of the faculty/staff strength in the Dr. Khem Singh Gill Akal College of Agriculture as per ICAR guidelines.

House approved it as there was no comment/suggestion from any of the members.

27/04/2021 - Approval of Balance Sheet for the financial year 2019-20

Dr. SK Chauhan told that the Balance Sheet and Audit Report for the financial year 2019-20 was also circulated among the Hon'ble members. Dr. Jai Kumar Sharma, Chief Finance & Account Officer was requested to present the Balance Sheet in the house.

Dr. Jai Kumar Sharma informed the house that this item was also placed in the Planning Board meeting, Finance Committee meeting, Academic Council meeting held on 12th march 2021 and Board of Management meeting held on 27th March 2021.

Dr. Jai Kumar Sharma said that the Balance Sheet and Audit Report for the financial year 2019-20 was prepared as on 31st March 2020. This balance sheet is to be submitted to the Himachal Pradesh Government and Regulatory Commission under the provision of clause 39 of Eternal University (Establishment and Regulation) Act No 03 of 2009 and its amendments from time to time. He further stated that the University Liabilities as well as Assets amount to Rs 37, 27, 13, 442.78 (Rupees thirty seven crores, twenty seven lacs, thirteen thousands, four hundred forty two and paisa seventy eight only).

Dr. Jai Kumar Sharma further added that this Balance sheet for the financial year 2019-20 has also been scrutinized by Chartered Accountant, Mr. Dinesh Kumar Sood, Shimla.

Dr. Jai Kumar Sharma requested the Hon'ble members to give any suggestion/comments for this item.

As there was no suggestion/comment about the Audit Report & Balance Sheet for the financial year 2019-20, the house approved it.

27/05/2021: Approval of the Estimated Budget for Financial Year 2021-22

Dr. SK Chauhan told that the estimated Annual Budget for the financial year 2021-22 was also circulated among the Hon'ble members along with the notice of the meeting and Dr. Jai Kumar Sharma, Chief Finance & Account Officer was requested to present the Annual Budget 2021-22 in the house.

Dr. Jai Kumar Sharma informed the house that this item was also placed in the Planning Board meeting, Finance Committee meeting, Academic Council meeting held on 12th march 2021 and Board of Management meeting held on 27th March 2021.

Dr. Jai Kumar Sharma informed the house that the Annual Budget for the next financial year i.e. 2021-22 has been prepared depicting a comparative statement of the last three years. The annual income and expenditure for the financial year 2018-19 and 2019-20 have been placed as per actual and the income & expenditure for the current financial year (2020-21) have been revised which include the estimated income & expenditure for the month of March, 2020. The budgeted income for the financial year 2021-22 has been planned on the basis of estimated income from students' fee, various grants (Projects), boarding & lodging collection from the faculty and staff, interest on FDRs and return from dairy complex etc. whereas the expenditure has been proposed under 35 different heads. Dr. Jai Kumar Sharma presented the budget head wise and concluded that the realized budget surplus over the expenditure if any will be transferred to the Kalgidhar Trust i.e. parental body of the University for completing the construction of Agriculture College and other infrastructure in the University.

Dr. Jai Kumar Sharma told that some of the clarifications/suggestions came forward from the Hon'ble members in the Planning Board and Finance Committee Meeting have been rectified in the budget placed in the house.

Dr. Jai Kumar Sharma requested the Hon'ble members to give any more valuable suggestion/comment on the budget proposed for FY 2021-22.

The house **approved** the annual budget for the financial year 2021-22.

27/06/2021: Superannuation Policy for the Eternal University Employees

Dr. SK Chauhan said that this item was circulated to all the Hon'ble members along with the notice of the meeting and was also placed in the Board of Management meeting on 27th March, 2021.

Dr.SK Chauhan told that the superannuation policy for the University regular employees has not been laid down in the Eternal University Act and Statue; however, the rules laid down by the Government Universities in the state of Himachal Pradesh may be followed by Eternal University.

Dr. SK Chauhan explained that as per the laid down policy by the HP State Government Universities such as Dr. Yaswant Singh Parmar University of Horticulture and Forestry, Solan, CSK HPKV, Palampur, HP Technical University, Hamirpur and HP University, Shimla, the age of retirement is 60 years.

Dr. SK Chauhan said that at present, there are following types of faculty/staff serving in the Eternal University:

- (a) Regular up to 60 years.
- (b) Contractual up to 60 years (non superannuated category)
- (c) Contractual re-employed superannuated staff & teachers below and above 60 years.

The rule for superannuation will be applicable in case of (a) and (b) category. As per proposed policy, the (a) and (b) category regular and contractual employee of Eternal University shall retire from university service on the last day of the month in which he/she attains the age of 60 years. However, keeping in view the remote location of Eternal University in Sirmour district and non-availability of well qualified & experienced staff/faculty, the superannuated personnel based on his/her written request and excellent past record in the concerned area may be re-employed under (c) category up to the age of 70 years (being minority category University declared by MHRD) on annual contract basis for which fresh appointment letter on the recommendation of committee will be issued by the competent authority on mutually agreed remuneration. But at any stage if the performance is found unsatisfactory, his/her services may be terminated by the appointing authority by giving one month notice.

Dr. SK Chauhan further informed the house that the policy for superannuation has been laid down by two HP Government Universities in their statue, therefore, it is requested to the house that this ruling also to be followed by the Eternal University with immediate effect.

Hon'ble members present in the house agreed with the proposal and presentation made by Dr. SK Chauhan.

27/07/2021: Regularization of faculty

Dr. SK Chauahan said that this item was circulated to all the Hon'ble members along with the notice of the meeting and was also placed in the Board of Management meeting held on 27th March, 2021.

Dr. SK Chauhan said that the University is going to regularize the faculties who have completed their minimum 2 years' service in the university. The regularization of the faculty is also essential for getting the ICAR accreditation of Dr. Khem Singh Gill Akal College of Agriculture.

Dr. SK Chauhan told that 16 applications of the faculty from Dr. Khem Singh Gill Akal College of Agriculture and 07 applications from other college have been received by the VC's Office.

Dr. SK Chauhan informed the house that a selection committee is being constituted to process these applications by mid of April 2021.

Dr. SK Chauhan requested the Hon'ble members to give any comment/suggestion for this item.

As there was no suggestion/comment from any of the Hon'ble member, house approved it.

27/08/2021: Process to fill up the vacant posts of faculty/staff

Dr. SK Chauahan said that this item was circulated to all the Hon'ble members along with the notice of the meeting and was also placed in the Board of Management meeting held on 27th March, 2021.

Dr. SK Chauhan informed that the University is going to fill up some of the vacant posts in the teaching and non-teaching cadre. An advertisement for the post of Registrar, Controller of Examination, Finance Officer, Librarian, Professor/Associate Professor/Assistant Professor in the Dr. Khem Singh Gill Akal College of Agriculture, Akal of Education and Akal College of Engineering & Technology was published in the "The Tribune" Newspaper on 24th February 2021.

Dr. SK Chauhan said that the applications along with Bio-data were invited by 05th March 2021.

Dr. SK Chauhan said that in the light of the report and recommendation of the search cum selection committee, Hon'ble Baba Iqbal Singh, Chancellor, Eternal University appointed Dr. Davinder Singh as a Vice Chancellor of the Eternal University for a period of three year with effect from 19th December 2020.

27/10/2021: Appointment of Pro-Vice Chancellor

Dr. SK Chauahan said that this item was circulated to all the Hon'ble members along with the notice of the meeting.

Dr. SK Chauhan said that Hn'ble Baba Iqbal Singh, Chancellor of the Eternal University appointed Dr. AS Ahluwalia as Pro-Vice Chancellor under the clause of 16(1) of the Eternal University Act 2009 with effect from 09 August 2020 for a period of one year.

Former Vice Chancellor, Dr. HS Dhaliwal appreciated his appointment and conveyed his good wishes to Dr. AS Ahluwalia for joining the University as Pro-Vice Chancellor.

Dr. Davinder Singh said that Dr. AS Ahluwalia is having vast experience in academic as well as scientist expert professor basically from the Botany subject. He had served in Panjab University, Chandigarh for a long time. He is also a member of the Academic Council and Board of Management of the Akal University, Talwandi Saboo (Punjab).

Dr. SK Chauhan requested the Hon'ble members to give any valuable comment/suggestion for the appointment of Pro-Vice Chancellor.

As there was no suggestion/comment from any of the Hon'ble member, house approved it and the conveyed their good wishes to Dr. AS Ahluwalia.

Dr. AS Ahluwalia expressed his heartfelt thanks to everyone.

27/11/2021: Course approval 2021-22 - Reporting item

Dr. SK Chauhan said that the course approval letter for the academic session year 2021-22 was circulated among the Hon'ble members along with the notice of the meeting.

Dr. SK Chauhan said that a meeting for course approval was held at HP-PERC, Shimla on 15 February 2021. Dr. SK Chauhan informed that HP-PERC Shimla has approved 18 UG Courses, 28 PG Courses and 20 doctorate courses for the Academic Session 2021-22 and for all courses total 1075 seats have been approved.

Dr. SK Chauhan told that the seats as per demand have been approved by HP-PERC Shimla to the satisfaction of the University.

Dr. Neelam Kaur enquired about the difference of seats approval in comparison to the Academic Session 2020-21. Dr. AS Ahluwalia said that approximately 1134 seats were approved in 2020-21 and now the seats have been decreased due to dropping of some of the courses in which the admission status was poor for two years and in some of courses, the seats have been reduced keeping in view the intake of past 2-3 years..

Dr. Neelam Kaur desired a comparative table of the seats approval for current and next academic session. Dr. SK Chauhan assured that it will be provided by the Registrar Office soon.

Dr. Neelam Kaur suggested that for promoting the admission in the next academic session, a leaflet for all the approved courses be supplied to all the Academies of the Kalgidhar Trust as well as to Akal University, Talwandi Saboo, Punjab for their information and advertising in the areas of their jurisdiction. Dr. SK Chauhan said that Director, Admission & Placement will be advised to follow up this action.

Dr. Neelam Kaur appreciated the approval of two new "certificate courses" which are actually required for the institution. Dr. SK Chauhan said that these courses are approved with a clause for which Dr. Purvi Luniyal and Dr. Shaveta Menon have been directed to follow up the action before the commencement of the academic session.

Dr. SK Chauhan requested the Hon'ble members to any valuable suggestion/comments

. As there was no comment/suggestion, house approved this reporting item.

Dr. SK Chauhan said that the agenda listed items have been discussed thoroughly and Hon'ble members are requested to put forward any other suggestion/issue.

Dr. Neelam Kaur expressed great concern for the emerging issue of Covid-19 wherein new mutant of early COVID has been identified to be more dangerous in terms of its spread among human being. She told that one affected person with new virus may be chained with 406 personnel by end of 30 days. Therefore, the three main precautions viz hand washing every hour, maintaining social distance and wearing of mask be adhered to.
