Dr. Davinder Singh, Chancellor of the Eternal University welcomed all the Hon'ble members. Hon'ble Chancellor directed Dr. SK Chauhan, Additional Registrar to start the agenda as scheduled for the meeting.

Dr. SK Chauhan conveyed his thanks to the Hon'ble Chancellor and said that four of our external members namely Mr. Rajeev Bindal, Mrs. Reena Kashyap, Sh. Sunil Sharma and Mr. Harjit Singh could not attend the meeting and expressed their inability to join the meeting due to their pre-planned programme/activities.

Dr. SK Chauhan told that one of our beloved staff members Mr. Shobha Singh, Office Superintendent, Examination Branch of the Eternal University, Baru Sahib was suffering with his headache resulting which he met with his brain surgery in the IVY hospital during the last week of November, 2022 and remained under treatment for around three months. He completed his journey in this world and moved to rest in the feet of Almighty God on 01 March, 2023 in the afternoon. The university employees as well as students observed a condolence gathering on 02 March, 2023.

A copy of resolution for his condolence was read out by Dr. SK Chauhan and thereafter, house observed two minutes silence for grant of eternal peace to his departed soul and courage and strength to the bereaved family to bear the irreparable loss.

After sharing the above information, Dr. SK Chauhan started the listed agenda as under:

Item No 29/01/2022: Ratification of the Proceedings of the 28th Governing Body Meeting held on 01st April, 2022

Dr. SK Chauhan said that the proceedings of last Governing Body Meeting were circulated among the Hon'ble members on 28th February, 2023 and comments/suggestions were invited by 01st March, 2023. No comments/suggestions were received by the Registrar Office till the commencement of this meeting. However, some of the following important issues of last meeting were hereby updated as under:

(a) Amendment to Leave Rule (Item No 28/10/2022)

Dr. SK Chauhan said that in the last Governing Body meeting, the agenda for Paternity Leave, increasing the period of Maternity leave and three additional leave could not be approved.

Dr. SK Chauhan again suggested the following issues in the interest of the employees of the Eternal University:

- (a) A period of minimum **7 days paternity** leave may please be permitted against 15 days being followed in Government institutions.
- (b) **Maternity leave** period be increased to **90 days** instead of the existing **60 days** whereas Government is granting 180 days maternity leave in the Government institutions.
- (c) Permission for two/three leaves to the female employees viz Karva Chauth, Raksha Bandan and Bhaia Duj.

Hon'ble Chancellor as well the house **approved clause (a) & (b)** above with effect from 01st January, 2023, As regarding clause (c), Hon'ble Chancellor told that this clause will not be possible due to merging of existing four Restricted leave into Casual leave. At present all the employees are getting 12 days Casual Leave and interested ladies may apply her Casual Leave on such days.

(b) Padma Shri Jagjit Hara Excellence Award to progressive Farmer during Kissan Mela 2022 (Item No 28/11/2022)

Dr. SK Chauhan told that an amount of Rs. Rs. 5,00,000/- was donated by **Padma Shri Jagjit Hara** during March 2020 which has been kept in the form of FD. The interest accrued from FD is used for awarding cash prize, gold medal and citation for Progressive farmer and one for M. Sc. Ag. student obtaining the highest OCPA among all disciplines. Dr. HS Dhaliwal enquired about the interest earned so far on this Fixed Deposit amount. Dr. SK Chauhan replied that it may be around Rs. 60,000/- during the last two year period (2021-22 & 2022-23) out of which only Rs.10,000/- was utilized for one award to a progressive farmer in 2022. Dr. SK Chauhan further told that till date no award has been given to any of the students, anyhow, it will be awarded to a meritorious student in the 10th convocation likely to be held in the month of May 2023. Dr. HS Dhaliwal agreed with the justification given by Dr. SK Chauhan.

(c) Any other item with the permission of Chair (Item No 28/13/2022)

Dr. SK Chauhan told that some of the following points were received from our Hon'ble member Mr. Harjit Singh which were placed in the last Governing Body meeting:

- (a) How do we define growth of the Eternal University?
- (b) Do we have long term or short terms objectives defined at University and college level?
- (c) What are the action points to be taken during next year and how do we have plan to monitor and evaluate them.
- (d) Good to see that agenda talks about setting up research development centre, but there is no information about its plan and its timeline.

Dr. SK Chauhan told that a committee was constituted to address these points. However, formal notification of the committee from VC Secretariat is yet to be issued.

Dr. HS Dhaliwal said that these points seem to be difficult to achieve and lack clarity.

Hon'ble Chancellor said that the outcome of the committee will be discussed in the next meeting. The Pro-Vice Chancellor was requested to notify the committee soon.

Dr. SK Chauhan requested the members to give any comment/suggestion on these proceedings.

House **ratified** these proceedings as no further comment/suggestion received from any of the members.

29/02/2023: Approval for 10th Convocation

Dr. SK Chauhan told that this has been decided in the 55th Board of Management Meeting held on 17th February, 2023, that the 10th Annual Convocation be scheduled on first non working Saturday i.e. 06th May 2023.

House agreed with the date proposed for the 10th convocation. Hon'ble Chancellor advised Dr. NP Singh to nominate & invite such a Chief Guest preferably from whom the university may get some research funding for various projects. Dr. NP Singh agreed with the advice of Hon'ble Chancellor.

(Action: Dean Reserch and COE)

29/03/2023: Compliance report sent to HP-PERC against the recommendation of Inspection team dated 14-15 December, 2022.

Dr. SK Chauhan said that an inspection team constituted by HP-PERC for the approval of various UG, PG courses run by the University during academic session 2023-24, inspected the University on 14-15th December, 2022. HP-PERC conveyed some of the points observed by the inspection team to the University and asked for its action taken report on an affidavit. The reply was forwarded accordingly. The observations as well as the reply to these observations were also conveyed to all the Hon'ble members along with the agenda of the meeting.

However, Dr. SK Chauhan highlighted some of the following major observations:

- (a) HP Govt is pressing hard for the employability of 80% Himachalies in Class III and IV categories. Dr. SK Chauhan told that the Trust is managing this issue and will be resolved shortly. While intervening, Dr. HS Dhaliwal said that the reservation policy for 80% of Himachalies will not be applicable for our University being having the status of Minority institution.
- (b) UGC pay scale should be implemented as early as possible. Dr. SK Chauhan told that this aspect is also related to the Parental Body i.e. Kalgidhar Trust and may be decided in the Governing Body meeting. Regarding implementation of UGC pay scale Dr. HS Dhaliwal said that it is also not an easy task because till now some of the Government departments have also not implemented these scales.
- (c) As regarding promotion policy, the University will endeavour to follow the spirit and guidelines of UGC in general. Dr. AS Ahluwalia, Pro-Vice Chancellor said that applications from candidates have been invited to examine their suitability for promotion and salary enhancement.
- (d) The observation for filling up the post of Registrar and Chief Accountant & Finance Officer, a suitable person will be employed as & when interviewed by the University administration. Dr. HS Dhaliwal suggested to appoint a suitable person for the Job of Registrar being vacant since last three years and Chief Finance & Account Officer since last year. In a quick response, Hon'ble Chancellor suggested the name of Mr. BS Kapoor for the duties of Chief Finance & Account Officer of the Eternal University and Registrar will be appointed once a suitable person found & interviewed.

House agreed with the suggestions of Hon'ble Chancellor and Dr. HS Dhaliwal.

29/04/2023: Regarding age bar of faculty and other authorities as per UGC/AICTE norms

Dr. SK Chauhan informed the house that HP-PERC is very much concerned to adhere to the norms with reference to age bar of faculty and other authorities set by the UGC/AICTE and other Central/State regulatory bodies, failing which action may be deemed fit shall be initiated against the default institutions. Dr. SK Chauhan further told that under the provision of UGC Model guidelines, **a re-employed superannuated teacher shall not be eligible for holding administrative or financial responsibilities at the institution or elsewhere.**

Keeping in view of the above, Hon'ble Chancellor decided to follow up the age bar criteria either for the serving or for the re-employed superannuated teachers. He further said that if any of the teachers has been given any of such administrative or financial responsibility after attaining the age of 70 years, **it will be withdrawn with immediate effect and to be ensured in future.**

House agreed the decision of Hon'ble Chancellor.

29/05/2023 Formation of search committee for the Appointment of Vice-Chancellor

Dr. SK Chauhan informed the house that under the provision of Clause 13 of Eternal University (Establishment and Regulation) Act 2009, our Hon'ble Vice-Chancellor is completing

his first tenure of three years on 18th December, 2023, thus a research committee for the appointment/re-appointment of Vice-Chancellor need to be constituted timely (at least three months before the date of completion) so that the Government of Himachal Pradesh may be informed well in advance i.e. before the completion of tenure of present Vice-Chancellor.

House agreed with the justification of Dr. SK Chauhan.

29/06/2021 Approval for the Requirement & Appointment of EU Official Staff

Dr. SK Chauhan presented this item himself and proposed the following minimum cadre strength for the offices of Vice-Chancellor's Secretariat, Registrar, Controller of Examination, Dean Academic Affairs, Dean PGS and Accounts. He said that these offices are having their paramount importance in the University functioning. The minimum official staff as shown against each is essential for the smooth functioning as well as updating the records from time to time for meeting out the urgent requirement of UGC, NIRF, AISHE, HP-PERC and Directorate of Higher Education, Shimla as & when asked for on a very short time:

Dr. SK Chauhan requested the house to accord approval for the above cadre strength and to appoint them at University level with proper interview and the rules of the University should also be applicable for such selected persons so that they may accomplish their official duty with great zeal and honesty.

Hon'ble Chancellor **approved** the above cadre strength but keeping in view of some other issues like inter university transfer as well as to maintain proper discipline among these employees, they will only be employed by the Kalgidhar Trust with proper interview and the rules of Kalgidhar Trust will be applicable for such official staff.

House agreed with the decision of Hon'ble Chancellor.

29/07/2023 Final approval of the Annual Estimated Budget for the Financial Year 2023-24

Dr. SK Chauhan told that the proposed budget for the financial year 2023-24 has been circulated among the Hon'ble members. Mr. Amandeep Singh, Accountant, of Eternal University was requested to present the budget for the next financial year 2023-24 in the house.

Mr. Amandeep Singh informed the house that the Annual Budget for the next financial year i.e. 2023-24 has been prepared depicting a comparative statement of the last three years. The Annual income and expenditure for the financial years 2020-21 and 2021-22 have been placed as per actual and the income & expenditure for the current financial year (2022-23) have been revised which includes the estimated income & expenditure for the month of March, 2023. The budgeted income for the financial year 2023-24 has been planned on the basis of estimated income from students' fee, various research projects grants; Boarding & Lodging charges collection from the faculty and staff, interest on FDRs and return from dairy unit and other heads, whereas the expenditure has been proposed under 37 different heads. Mr. Amandeep Singh presented the budget head wise and concluded that the realized budget surplus over the expenditure, if any, will be transferred to the Kalgidhar Trust i.e. parental body of the University for completing the construction work of Agriculture College and other infrastructure in the University.

Mr. Amandeep Singh told the house that this estimated Budget was initially placed in the Planning Board Meeting held on 17 February, 2023 in which some of the following valuable suggestions were given by Dr. DK Sharma.

- (i) In the income side, he said that all the projects are going to close during the current financial year and no amount has been proposed in the next financial year. He requested the Hon'ble Chairman to encourage and train the faculty members to submit new project proposals to the prospective funding agencies. Dr. AS Ahluwalia replied that some of the projects like NABARD are still under the consideration at Government level and it is hoped that these may be sanctioned at the end of this financial year. Dr. DK Sharma also suggested to prepare new projects like "women oriented programmes with specific reference to their socio-economic empowerment and skill enhancement".
- (ii) Dr. DK Sharma further told that the projects listed at Ser No 3 and Ser No 6 are not having any financial value thus these entries should be deleted.
- (iii) Dr. DK Sharma said that an amount of Rs 41.20 lakh proposed to utilize for Admission process and Advertisement seems to be too high in comparison to the actual expenditure made during the last three years.
- (iv) He also sought clarification on expenditure amounting to Rs 16.20 lakh shown against Ser No 27 (Conferences, Symposia, Workshop, FDP etc) against Rs. 4.00 lakh during last three years. It requires to be carefully looked into.

- (v) He also said that expenditure amounting to Rs. 15.45 lakh proposed against Ser No 37 (Miscellaneous Expenses) will not be sufficient if the University has to revise the pay scales as per 6th and 7th Pay commission and also proposed to release some dearness allowances. Dr. DK Sharma suggested to increase the amount against this head.

Mr. Amandeep Singh confirmed the house that the above suggestions have been incorporated in the budget placed in the house for its final approval.

Mr. Amandeep Singh requested the members to give any other valuable comment/suggestion.

Dr. SK Chauhan further told that in the 55th Board of Management meeting held on 17th February, 2023, Hon'ble Vice Chancellor also accorded his kind approval for the payment of the annual increment with effect from 01st April, 2023 to all the eligible employees of the University who will complete their one year service after last increment by 31st March, 2023 and to remaining (new appointees) from the date of completing their one year service. Dr. SK Chauhan also said that the decision for release of dearness allowance has been kept pending.

As there was no other comment/suggestion from any of the members, the Annual Estimated Budget for the financial year 2023-24 was **approved**.

29/08/2023 Balance sheet for the financial year 2021-22 (Reporting item)

Dr. SK Chauhan told that the balance sheet and Audit Report for the financial year 2021-22 was also circulated among the Hon'ble members. Mr. Amandeep Singh, Accountant, was requested to present the balance sheet in the house.

Mr. Amandeep Singh said that the balance sheet and Audit Report for the financial year 2021-22 were prepared as on 31st March 2022. These are to be submitted to the Himachal Pradesh Government and Regulatory Commission under the provision of clause 39 of Eternal University (Establishment and Regulation) Act No 03 of 2009 along with its amendments. He further stated that the University Liabilities as well as Assets amounting to Rs 39,66,80,288.56 (Rupees thirty nine crores, sixty six lakhs, eighty thousands, two hundred eighty eight and paise fifty six only).

Mr. Amandeep Singh further added that this balance sheet for the financial year 2021-22 has also been vetted by Chartered Accountant, Mr. KN Chandla, Shimla.

Dr. HS Dhaliwal observed that the expenditure organizing the various functions/festivals is only Rs 693/- through out a financial year. Mr. Amandeep Singh replied that some of the expenditure on such activities are met by the Kalgidhar Trust which have not been shown in the balance sheet of the Eternal University expenditure, however, it will be ensured for the future.

As there was no query about the Audit Report & balance sheet for the financial year 2021-22, the house **approved** it.

29/09/2023: Fourteenth (14th) Annual Report for the Academic Session 2021-22 (Reporting item)

Dr. SK Chauhan presented this item and informed the house that 14th Annual Report for the Academic Session 2021-22 was prepared with utmost care and the relevant information got from all the constituent colleges and various departments. The contents of this report were also circulated to all the Hon'ble members; moreover, hard copies of this report has also been supplied to all the members through registered post.

Dr. SK Chauhan requested the members to give any valuable suggestion/comment which may be considered in the next annual report.

Dr. HS Dhaliwal appreciated the work done for preparation of this report and said that this report is much better in comparison to Punjab Agricultural University, Ludhiana. He also suggested that it will be more beneficial if the research component be given in an elaborated form.

House agreed with this valuable suggestion given by Dr. HS Dhaliwal.

As there was no other comment/suggestion, house approved it.

29/10/2023 ICAR Accreditation (Reporting Item)

Dr. SK Chauhan told that National Agricultural Education Accreditation Board (NAEAB), ICAR New Delhi has approved the accreditation for B. Sc. (Hons) Agriculture degree programme for five years i.e. 19 July 2022 to 18 July 2027 whereas five master courses have not been accredited due to insufficient faculty. Moreover, the college was also not accredited due to non-accreditation of master courses.

Further Dr. SK Chauhan told that following five conditions have been laid down by ICAR to keep stand good our accreditation:

- (a) Upload SSR on the University web site.
- (b) Upload annual intake data of the students on the University website.
- (c) To maintain student intake capacity for the accredited programme.
- (d) Strength of faculty, staff & technical staff must be maintained.
- (e) Mid-term review will be conducted.

Dr. SK Chauhan informed the Chair that the construction work of DKSGACA new building, seems to be standstill and it may affect for the next accreditation either for the college or master programmes.

Hon'ble Chancellor replied that it is a matter of confusion whether the existing building will be continuously used till the process of next accreditation or the new building is to be shown to the ICAR team as & when they come. Hon'ble Chancellor suggested Dr. SK Chauhan to discuss the matter with Dean, DKSGACA and let him know the next ICAR accreditation process so that the new building of DKSGACA may be completed.

Dr. HS Dhaliwal also said that all the 60 seats in the B. Sc. (Hons) Agriculture programme must be filled up from the next academic session onward. Dr. HS Dhaliwal also suggested for the wide publicity of the University through hoarding on the visible sites at various important locations.
