Dr. Shanta, Associate Professor of the Department of Economics presented the 2<sup>nd</sup> item on the proposal for the approval of course structure of M.Sc. Economics with and without thesis. Dr. Sudhanshu Maurya, Associate Professor of CSE suggested that credit seminar (1+0) should be included in the fourth sem of M.Sc. Economics without thesis and it was endorsed by majority of members of the house. After the discussion, the item was approved by the house.

Next agenda item 3<sup>rd</sup> was presented by the Dr. Kajal Chaudhary regarding the proposal for the approval of course structure for M.Com programme. The chairmen of the house directed to relook the structure of the programme and also design in the form of with and without thesis. Therefore, the agenda item was deferred for the further meeting.

Dr. Shanta requested Dr. Manjinder Kaur followed by Dr. Kajal Chaudhary, Mr. Amit Kumar and Dr. Tusshar Mahajan to present the 4<sup>th</sup> item regarding the approval of the course schedule of B.Sc. (Hons.) Economics, B.Com (Hons.), BBA and MBA as per the guidelines of NEP,


2020, orderly. After the presentation of the respective faculty, members of the house made thorough discussion. It was directed by the chairperson that all the departments in their undergraduate programme should use same course code for the common subjects like Ability Enhancement Courses (AEC), Skill Enhancement Courses (SEC), Multidisciplinary Courses (MDC), Value Added Courses (VAC) and it was supported by the Dr. Surjan and rest of the members of the house. Likewise, for the MBA programme Dr. Sudhanshu Maurya suggested that MBA 595-Summer Training should be shifted from 2<sup>nd</sup> semester to the 3<sup>rd</sup> semester to reduce the load of the credits in the 2<sup>nd</sup> semester. Finally the items were approved by the house.

**(Action to be taken by Dr. Manjinder, Dr. Kajal, Mr. Amit & Dr. Tusshar)**

Next agenda (7/5/2023) presented by Dr. Tusshar Mahajan which was regarding the approval of course structure of MBA in Business Analytics specialization. After through discussion the agenda item with regard to course structure was approved by house and it was agreed upon to design the detailed course syllabi henceforth for approval as per laid down procedures.

At the end, Chairman of the house extended thanks to members of the house, special invitees and the member secretary for their participation and valuable suggestions. Thereafter, the meeting was ended with vote of thanks to the chair.
