

### 58/8/2018 Approval of Ph. D. Renewable Energy Syllabus

Dr. Ramesh Arora again requested Dr. Sudhakar Pandey to present the item.

Dr. Sudhakar Pandey said that during the Academic Session 2017-18 two seats were approved by the HP-PERC in the Ph. D. Renewable Energy but no admission was made.

pr. Sudhakar Pandey said that keeping in view the approval of these seats, the curriculum was framed.

Hon'ble Vice Chancellor asked about the approval of seats as well as the admission status for the Academic Session 2017-18 and 2018-19. Dr. Sudhakar Pandey replied that neither the approval of Ph. D Renewable Energy was accorded by the HP-PERC nor any admission had made during these two academic sessions.

Dr. Davinder Singh said that the cost of teaching for one Ph. D. Student will be too high.

Hon'ble Vice Chancellor also enquired about the admission of M. Tech Renewable Energy in the Academic Session 2017-18 & 2018-19. Dr. Sudhakar Pandey replied that no student got admitted in these two academic years against the approval of 18 seats in each year. Hon'ble Vice Chancellor said that if there is no student in the M. Tech Renewable Energy, no approval for Ph.D. will be given by HP-PERC.

Dr. Sudhakar Pandey requested the house to approve the syllabus to meet the requirement in future.

House approved the syllabus as requested by Dr. Sudhakar Pandey.
