WHEREAS, in terms of section 14(1) of the NCTE Act, 1993 Akal College of Education, Plot No.-45, Baru Sahib, Tehsil- Pachhad, District- Sirmour - 173101, Himachal Pradesh had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for B.Ed Course of one year duration with an annual intake of 100 (Hundred Only) students on 26.10.2009.

AND WHEREAS, the deficiency letter issued to the institution on 30.04.2010 and the reply of the institution (in response to deficiency letter) was considered by the committee in its 157th Meeting held from 24th to 27th March, 2010 and committee decided to LOI may be issued.

AND WHEREAS, the inspection of the institution was conducted on 18.05.2010 and the application submitted by the institution, the documents attached therewith, the affidavit, input received from the visiting team in the form of report/ videography and the input received from, recommendation of the State Government, the Northern Regional Committee in its 161st Meeting held from 26th to 29th May, 2010 and NRC decided to issue letter of intent under clause 7(9) of regulations 2007. Accordingly, letter of intent under clause 7(9) was issued to the institution on 13.07.2010.

AND WHEREAS, the reply of the Institution received on 14.10.2010 w.r.t. the show-cause notice has been considered by the NRC in its 171st meeting held on October 28-29, 2010 and committee decided to clarification. Accordingly, clarification letter was issued to the institution on 18.11.2010. The reply of the institution dated 4th December, 2010 has been considered by the NRC, in its 178th meeting held from February 8-10, 2011 and committee decided to clarification.

AND WHEREAS, the reply of the institution dated 16.05.2011 and alongwith earlier reply dt. 04.12.2010 and the original file was considered by NRC in its 183rd (2nd setting) Meeting held from 08th to 14th June, 2011 and NRC decided that the Formal Recognition order under clause 7(11) of the NCTE Regulation, 2009 for 100 seats in B.Ed. course for the session 2011-2012 be issued to the institution.

NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to Akal College of Education, Plot No.-45, Baru Sahib, Tehsil- Pachhad, District- Sirmour - 173101, Himachal Pradesh for conducting B.Ed. One year Course with an annual intake of 100 (Hundred Only) students from the academic session 2011-2012 under clause 7(11) of NCTE Regulations subject to the following conditions:

- The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated alongwith an officer of the Northern Regional Committee.
- The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2009.

Further, the recognition/permission is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc. wherever applicable.

The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.

The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -

- Copy of the Application Form
- Land and Building Particulars
- Staff Profile
- Recognition letter
- Information for having fulfilled the norms & standard and other required conditions.


